

2. The recognition is being conferred on your union under Code of Discipline and accordingly, this is subject to your union abiding by the Code of Discipline in letter and spirit.


3. While congratulating you on the success of your union, we look forward to your co-operation for maintaining harmonious industrial relations and also to further the organizational interest.
